CA-U CONTROLLED PARKING ZONE (CPZ) REVIEW

SECTION 1: INTRODUCTION

We would like to seek your views and those of other local groups in your CPZ on the hours of control that you wish to see in CA-U CPZ.

This letter is part of an initial engagement exercise which is the first stage of the review of CA-U. It is aimed at informing the development of options that will be included in a wider public consultation in January 2018.

The review of CA-U is being undertaken in response to Islington Council extending the hours of operation of its CPZ K to 24 hours; the extension was implemented in June 2017. As this Zone shares a boundary with Camden's CA-U, whose current hours of control are 10:00 – 12:00, Monday – Friday, there are concerns that some of those unable to park in Islington's Zone K may park in CA-U. The review is therefore aimed at addressing this and any other impacts of Islington's changes.

Section 2 sets out options for the hours of control for CA-U CPZ which we are considering to include in the wider consultation. SECTION 3: NEXT STEPS

Your views on all the questions will be collated and analysed. Following this, we shall hold a workshop for local groups and Ward Members in your CPZ in early December; the exact date will be confirmed following receipt of responses from this exercise. The intention of the workshop is discuss the responses received to the questions in Section 2 and to give local groups and ward members an opportunity to help shape the questions in the consultation material that will be used for the second formal consultation. Parking bay occupancy surveys have been undertaken to provide an understanding of the impacts of Islington's changes. The results of these surveys will be presented at the meeting to inform the discussion.

After the meeting, the second formal stage of the consultation will commence in January 2018. Under this, consultation documents will be sent to all postal addresses in the CPZ. The consultation will also be made available on Camden's website so that anyone can respond whether they live, work or visit each area. On-street notices will also be made available to alert those who visit the area by car to the consultation.

Following this, a report detailing the outcome of the consultation and recommendations in response to the consultation and survey results will be submitted to the Cabinet Member for Improving Camden's Environment for a decision.
